

## **Duty to Manage Asbestos**



Under Regulation 4 of the Control of Asbestos Regulations 2012, all non-domestic premises must have a Duty Holder who has ultimate responsibility to manage the asbestos in the premises.

#### **Course Overview**

This course is directed at those who manage non-domestic premises with responsibility for protecting others who work in such premises, or use them in other ways, from the risks to ill health that exposure to asbestos causes.

The content will provide the delegate with an understanding of the legislative requirements of Control of Asbestos Regulations 2012 (CAR2012) with particular reference to the Duty Holder and who that could be, the surveys available, what to expect in a survey and the asbestos management plan and its use and requirement.
